AKTA PERNIAGAAN PERKHIDMATAN WANG 2011

PERINTAH PERNIAGAAN PERKHIDMATAN WANG (PENGECUALIAN FI) 2011

PADA menjalankan kuasa yang diberikan oleh seksyen 91 Akta Perniagaan Perkhidmatan Wang 2011 [*Akta 731*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perniagaan Perkhidmatan Wang (Pengecualian Fi) 2011**.

(2) Perintah ini mula berkuat kuasa pada 1 Disember 2011.

Pengecualian fi

2. Menteri mengecualikan—

(a) institusi yang ditetapkan di bawah Akta Institusi Kewangan Pembangunan 2002 [*Akta 618*] yang telah dilesenkan untuk menjalankan perniagaan perkhidmatan wang; dan

(b) Pos Malaysia Berhad (No. Syarikat 229990-M) yang telah dilesenkan untuk menjalankan perniagaan pengiriman wang dalam ruang lingkup perkhidmatan kewangan pos yang dibenarkan di bawah seksyen 24 Akta Perkhidmatan Pos 1991 [*Akta 465*],

daripada kehendak seksyen 8 Akta Perniagaan Perkhidmatan Wang 2011.

MONEY SERVICES BUSINESS ACT 2011

MONEY SERVICES BUSINESS (EXEMPTION OF FEES) ORDER 2011

IN exercise of the powers conferred by section 91 of the Money Services Business Act 2011 [*Act 731*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Money Services Business (Exemption of Fees) Order 2011**.

(2) This Order comes into operation on 1 December 2011.

Exemption of fees

2. The Minister exempts—

(a) the prescribed institutions under the Development Financial Institutions Act 2002 [*Act 618*] which have been licensed to carry on money services business; and

(b) Pos Malaysia Berhad (Company No. 229990-M) which has been licensed to carry on remittance business which is within the scope of the postal financial services allowed under section 24 of the Postal Services Act 1991 [*Act 465*],

from the requirements of section 8 of the Money Services Business Act 2011.
